All members of the Board were present, with the exception of Director Gilliland, thus constituting a quorum. Also attending were J. William Petrov of Johnson Petrov LLP (the "Attorney" or "JP"), attorneys for the District; Jon Strange of JNS Engineers LLC (the "Engineer") and Dane Turner a representative of Best Trash LLC and several residents of the District.

The President, after finding that the notice of the meeting was posted as required by law and determining that a quorum of the Board was present, called the meeting to order and declared it open for such business as may regularly come before it.

1. Public Comment.

Members of the public were allowed to speak.

2. <u>Solid Waste Collection Contract</u>. Johnson Petrov received notice that USA Waste Solutions abruptly ceased operations and is no longer in business effective Friday, June 25, 2022.

Mr. Turner, a representative of Best Trash LLC stated that Best Trash would be able to assume garbage and recycling services to the Pin Oak residents, with the exception of moving the Wednesday recycling to a Saturday pick-up. He reviewed with the Board the Solid Waste Collection Contract, a copy of which is attached hereto as Exhibit "A".

Upon motion by Director Berckenhoff, seconded by Director Comeaux, after full discussion and with all Directors present voting aye, the Board approved the Solid Waste Collection Contract with Best Trash.

3. Quadvest Assignment Contract for Water and Wastewater Services.

Mr. Petrov reviewed with the Board an Assignment Contract for water and wastewater services to Quadvest, an Out-of-District customer.

No action was taken at this time.
